
Prizes were awarded to several catagories including: Traveled farthest distance, PHILIP J. GAST from Weisbaben Germany 4600 miles.





REMEMBER WHEN...

KELLEYS ISLAND SCHOOL PACT IS HELD ILLEGAL

The board of education of the kelleys island school district is without legal AUTHORITY TO ENTER INTO AN AGREEMENT WITH St. michael's parish providing for the use of parish schools for public school purposes, conditioned on the use of the text books of the Toledo diocese and the teaching of the TOLEDO DIOCESAN COURSE OF STUDY. Attorney General JOHN W. BRICKER rules in an opinion to prosecutor A.F.

The proposed agreement provided, among other things, that St. michael parish would allow the board to use the two classrooms of the parish school for elementary school purposes.


Since 1926 a Catholic elementary school has been maintained on kelleys island and the Catholic children of elementary school age have attended that school.


Difficulties now in financing the school resulted in the proposalthat these classrooms might be used by the public schools and that all Catholic children of St. michael parish should be allowed to attend.

BRICKER, on this point, ruled that the law gives to the county superintendent of schools the authority to assign pupils within the 'kelleys island school district, to whatever school he sees fit, and that the board of education is entirely without authority to make such assignment or to contract that any certain group of pupils may attend any particular school.

On the provision that the board should allow St. Michael's school, operated with public funds, to use the Toledo diocese textbooks and follow the prescribed Toledo diocesan course of studies, MR. BRICKER HELD.

I DO NOT HAVE BEFORE ME THE TEXT BOOKS IN QUESTION OR THE Toledo diocesan course of study, but if the books or the course of study involve the teaching of sectarian religion, it is clearly beyond the power of this board to bind itself by contract to use the books or to permit this course of study in the schools under its control or to which it contributes public school funds.

The bride was so beautiful in a dress of sheer material and lace, with a long train and a lace hat with veil hanging from the back.



HIGHLIGHTS OF AUGUST 5 COUNCIL MEETING COMPILED FROM MINUTES BY CAROL VOGLER BRIGHT

PRESENT: BIANCHI, MARTIN, MATSO, MYERS, SCHOCK, YOSCOVITS, Planning Commissioner Haig, Treasurer Seeholzer and other citizens.

COMMITTEE REPORTS: Finance - none.

LANDS AND BU-LDINGS: Matso states Business Peoples Assoc. is planning to sand, refinish and stain the pavilion park tables and benches and paint the posts. Mayor states that the Business People have also asked for the use of the Pavilion refrigerator to store soft drinks for the forthcoming Music Festival Day.

STREETS AND SIDEWALKS: Bianchi states that the State and Crew and equipment are working on straightening out Harbor Lane and roads and that H & S Blacktop men will be here next week with sweeper and equipment to clean up roads.

FIRE PEPARTMENT: Yoscovits stated that the department was able to save only the frame of the James Russell home due to fire damage. Mayor states a road on Monagon to be vacated on request of the owners.

At this point, Martin moved that the permission to vacate such road be sent to the Planning Commission for further study to determine whether it is a dedicated road or not.

AIRPORT: Haig reports \$26.00 deposited with clerk from the airport fee box. He again questions ordinance to govern illegal airport parking. Matso questions the reasoning for a beacon light at the airport.

CHIEF OF POLICE: 47 information calls


treasurer: receipts \$24,716.89, expenses \$14,385.25, balance is 65,982.95.

UNFINISHED BUSINESS

Mayor reads letter 8-4-82 from Solicitor William Smith concerning the conflict of the Mayor voting during any dispute that might be considered conflict of interest with his personal business. Mayor polls council as to their approval of the letter. All approve but Yoscovits votes no.

ISLAND ROADS AND THEIR REPAIR

Mayor McCune reported to council that BEATTY, BIANCHI AND the mayor met with Mr. Shultz from the H&S Inc. Co. to inspect all remaining roads on the island. Mr. Kenneth Polta, Erie Co. Engineer is to be informed of their findings. Martin and Bianchi will meet with Fred Deering, State Representative to investigate the possibility





MONARCH BUTTERFLY DAY SATURDAY SEPT. 18, 1982

The Kelleys Island Historical Association, Inc. will sponsor a Monarch Butterfly Day at 12 noon on Kelleys Island on Sept. 18, 1982. This is the first annual event for the Historical Association and will begin with a parade featuring the BUTTERFLY QUEEN from the boat landing to the German Reformed Church on Division Street. The church is now housing the association's collection and it is the location of their meetings.

The event will be followed by a bake sale, bazaar, craft tables, food and children's games.

Dr. Harold Mahan, Director of the Cleveland Museum of Natural History will lecture on the Monarch Butterfly which stops on Kelleys Island before migrating in large flocks to Mexico.

A special tagging session led by Dr. Maham will help demonstrate the distance these small creatures travel. Thirty monarch will be released to signify migration.

Proceeds from this special event will go for the renovation of the German Reformed Church (the old Stone Church) new home of the Historical Association.

Jaster asks whom he should sue if his property is damaged during lack of flood insurance since he cannot obtain it at present time since council does not belong to the flood program.


Mayor states KENNETH HAIG has automatically become building inspector, as he is planning board head, until Mayor appoints a new inspector.

Open Water Appears Between Mainland and Islands



KELLEYS ISLAND, March 9 Automobile and ice boat traffic between this island and the mainland was halted today with the appearance of a large gap of open water in the direction of Lakeside. The ice has started breaking up, piling on the west shore on the island and also drifting slowly eastward.

Walter Elfers was the last resident of the island to operate an automobile across the ice bridge with merchandise. The trip, which he made Thursday, was a long and circuitous one to the far west of the island. Ice boats can still cross far west but are not risking trips because ice has been found thin in many fields.

Owners of ice fishing shanties have moved their buildings much farther toward shore and most of the fishing is now being done on the north side of the islands where the ice is still quite thick.

Licensed fishermen are preparing their nets to be loaded into boats for setting as soon as an open route is made between the island and Sandusky where the boats are kept through the winter.
