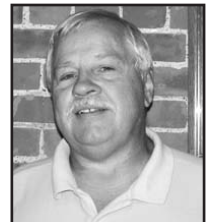

# A Man for All Seasons - In tribute to Bob Quinn

He was our friend. Coming as we both did 'later' to the island (a popular t-shirt reads, "I wasn't born here but I got here as fast as I could"), our friendship with Bob developed as we ran into each other at mutually attended events—senior lunch, graduation, school plays, e.g. The bond between Charlie and Bob grew easily, comfortably, naturally out of their simple good humor, shared kindness, and principles of helpfulness and respect for others.

It was not a likely friendship: they came from very different backgrounds

of experience, interests; different economies and social circles, different religious affiliations, and nearly opposite political persuasions emanating from their separate experiences in different historical events in US history. But their overarching respect for each other trumped the social barriers that often separate us into cliqueish groupings which depend on sameness for survival. Bob's world traveling business acumen meshed with Charlie's almost sublimely genuine and open person-

ality to form a sort of unplanned

coalition for good. While Bob wasn't exactly a 'mover and shaker,' he was not satisfied to let the status quo determine unnecessary, undesirable, and unpleasant outcomes.

Two examples are the airport runway and Kelleys Island Estes School. As in any community, there is often talk of what 'needs to be done' to fix the evident erosions over time weathered surfaces that make landing more tricky, even dangerous; declining enrollments and escalating costs of educating even one child. Instead of mere social chatter that bemoans the condition yet chalks it all up to something everyone's seen before and no one can do anything about, Bob got to work, studying the situation, exploring options, seeing what else was out there, what community leaders and innovative, committed community groups were doing in other

places to address the needs growing more apparent and more important on Kelleys Island.

Being fair and firm, yet friendly and well-liked is no easy task to accomplish. The latter is much easier

if you ignore the former. Bob found a way to be true to principles without confrontation or arrogant suppression of opposing views. He simply stood for what was right, and consistently held his ground to accomplish it. He located resources and studied the situation, bringing knowledge and information that provided leadership to effect change.

Along the way, Charlie and he found ways to have a little fun at each other's expense as well—all in good cheer. When Bob called to ask Charlie the 'dress code' for his first stage appearance as a school board member for graduation, Charlie told Bob the dress was 'casual.' Charlie wore a coat and tie; Bob didn't. Bob sweated for other reasons than the heat. At a moment of silence in the program, Charlie told Bob everyone was waiting for him to start the recession of the platform party from the stage. As Bob stood up and started across the stage, he quickly realized he had been "had," and thus began a 'gotcha!' game between the two. Yet Bob was equally quick to offer transport to a meeting, sensitive to the transporta-

tion needs of other islanders who could not drive after dark or could not walk long distances. He is responsible for bringing us the unrepayable gift of our furry four-footed friend, Guinness. Well educated and with an enviable international career in which he garnered respect from associates for his business prowess, Bob was both a scholar and a gentleman in his civility with others.

Bob Quinn was a classic Renaissance man: a man of moderate but refined tastes, a kind heart, a warm laugh and a wry smile. Bob was a sincere advocate for ensuring quality of life on our little island in the middle of the lake—his adopted home, where he found peace, comfort, and immense pleasure in a quieter corner of the universe. A remarkable life, well invested in people and laudable interests or causes throughout the wide itinerary of his life's journey. Not only a good man, says Charlie, but a great man. How lucky we were that Bob shared a little of that special life with us! He was indeed our friend.

Along with your family, the Village of Kelleys Island has suffered a great loss with the recent and sudden passing of Terry Kranyak. Terry provided dedicated and committed service standing for the rights of residents, property owners, and business entrepreneurs of Kelleys Island. He was diligent and faithful in examina-

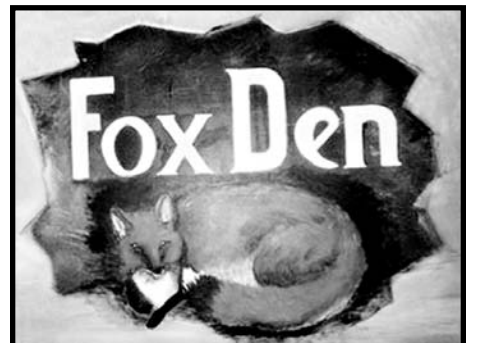

## Request for a "Vision!"

Last night I was asked to put together a brief article on my "vision" as a newly elected School Board member. Before I'm presumptuous enough to offer my "vision," I'd like to thank all who supported me through the election, especially those families who contributed front yard dirt for my 15 yard signs: Feyedelem's, Finnegan's, Jorski's, Campbell's, Reinhart's, Zimmerman's, Stevenson's, Gillis', Algase's, Marchky's, Lahrs', Wideman's, Huntley's, Ransom's, and Bickley's. It's much appreciated; thank you!

The "vision" that one has before and during an election, often adjusts when faced with the realities of the job ... I have yet to face those realities since I don't "Sit" until 1/1/10. But I've already had the privilege of sitting in on a handful of board meetings, first as an interested citizen and then as a non-voting participant. And further, I've participated in a three-day Columbus conference for Statewide School Board Members and School Administrators.

This conference was as intense as an individual wanted it to be, and very educational. Because I've been asked to serve as the Board's Legislative Liaison, I focused my conference attention on sessions involving House Bill 1, the School Funding

System, House Bill 318, the Governor's funding solution and related tax issues. This tax world, and how it impacts School Boards, is a complex one, and I've just scratched its crusty surface.

My brief Board experiences and conference exposure have just started to give me a taste of those "realities," as well as the many complex challenges facing the board. Dealing with the consequences and options of a decreasing enrollment, helping to maintain and enhance student programs, fostering digital options and initiatives for traditional, non-traditional and adult students, encouraging focused teacher and administrator development, involving parents and the community, are just a few of these challenges. All must be deftly handled with fiscal justification, accountability and transparency.

When someone asks you for your "vision," I suspect they're really asking for insight; your thoughts about answers and solutions. Right now my "vision" isn't about perception or intuition, it's all about asking questions and very much about the hard work and harder decisions facing all of your School Board Members in the years to come.

And thanks for the opportunity to be part of this "vision."

## Wintertime Island Air Transportation

With the approach of winter upon us and the freezing of Lake Erie, the mode of transportation changes from ferry to air. Last year, Griffing personnel announced a move for ALL island flights to Port Clinton a decision based on increasing efficiency, dealing with rising fuel costs, and keeping fares reasonable. Flights to Port Clinton from Kelleys Island will resume on December 1, 2009. Please familiarize yourself with the policies and view their website ([www.griffingflyingservice.com](http://www.griffingflyingservice.com)) or contact them directly at 419-734-5400. The transportation costs listed includes taxes, etc. Following are the winter policies and transportation costs for this coming year.

### FLIGHT POLICIES

- ALL passengers and ALL freight flights will depart and arrive from Port Clinton only.

- No flights will be offered to or from Sandusky.

- The Griffing staff will be available in Port Clinton for reservations beginning November 1, 2008. The phononumber for reservations is 419-734-5400.

- All cancellations and changes require 1 hour advance notice from departure time or you will be billed the normal seat fare.

- Please arrive 15 minutes prior to departure time.

- Upon reservation let us know if you will have more than 2 items (12x12x24" each), heavy items, large items, dogs, or any special physical needs.

- Credit card information will be required at the time of reservation. Cash will also be accepted at the time of the flight. NO CHECKS.

- To expedite reservations and travel, let us know if you want us to keep your credit card on file and we will run it at the time of flight.

- Unaccompanied children \$47.00 each way. (inter-island fares add \$1.00 for each island)

### FREIGHT POLICIES

- Please inform your suppliers (including pharmacies) that they must deliver all packages and freight to the Port Clinton Airport (3255 E. State Rd. Port Clinton, OH43452)

- U.S. Mail, UPS, Fed Ex, DHL, etc. will all be delivered to Port Clinton.

- DHL freight will be accepted; however the island customer will be billed.

- Payment will be required before any freight will be delivered to or from any island by credit card on file, prepayment, or drop-off person. NO C.O.D.'s will be permitted

- We request that all freight be labeled with: to and from names, island or mainland, and a phone number. Please label if item is perishable or fragile.

- For any overdue UPS, Fed Ex, or DHL packages please track online before our office.

- Guaranteed baggage is limited to two 12x12x24" and up to 35#-total weight.

- Additional baggage/luggage/freight -all items up to 12x12x24" and up to 35# - \$7.50 per package. Shipped

The Kelleys Island Historical Association (KIHA) is proud to present our new landscaping in front of the Old Stone Church and the installation of a brick "Memory Walk" in front of our new building. Islanders and island supporters will now have a unique opportunity to literally put their support or the island in stone, and have their family name or sayings remembered forever.

The KIHA board met with Thompson Landscaping during the month of May to plan and design a brick memory walkway, and to choose the shrubs, trees and plants to enhance our new landscaping. The lilacs in front of the Old Stone Church were in such bad shape that they could not be saved, so they were replaced with two pink flowering dwarf dogwood trees that are appropriate for the island. A permanent location for the stone bench in memory of Betsy Walcott which was given to us by the Mad Hatters was included in the design plan.

Landscape work was done when weather permitted on July 7th through the 10th with eight men carefully hand carrying the thousand pound granite bench to its new, permanent location.

Other plantings included: dwarf red barberries, winter gem boxwoods, blue princess hollies, sea green junipers, stella doro lily, and a flowering beech.

Now that the 4 foot x 91 foot limestone/sandstone mix brick walkway is complete, the Kelleys Island Historical Association is selling engraved bricks to replace the blank bricks in the "Memory Walk." You can purchase a blank brick - two different sizes are available for purchase, and we will have it engraved for you with your name, boat, or a loved one to leave as a permanent mark on the island. An order blank form is below and/or available at the museum gift shop, or in our next issue of the KIHA newsletter- which everyone who is a member receives. Don't miss this opportunity.

ties: windsurfing, kayaking, roller blading, bike riding, and running. The Kelleys Island Audubon Society has received memorial contributions in Terry's name. ## From the Kelleys Island Volunteer Fire Department

### Why do I need a burn permit?

Burning on Kelleys is authorized by permit only under very specific circumstances outlined in Section 93.52 of the Code of Ordinances of the Village of Kelleys Island.

### What can I burn?

No materials other than agricultural waste is permitted to be burned. Burning of materials containing rubbish, garbage, rubber, grease, asphalt, liquid petroleum products, building materials, shingles, or any product other than agricultural waster constitutes an EPA violation.

### How do I get a burn permit?

This permit may be obtained from the

Village Office. Office hours are Tuesday through Friday 12:30-4:30pm and Saturday from 9:00am-12:00pm. The permit must be filled out in its entirety and returned to the Village office by Tuesday at 3:00pm. A fire department official will then go out to inspect the burn site and if everything is satisfactory, the permit will be signed by the Fire and Police Dept. and then will be available for pick up on Wednesday. A copy of this permit must be carried by the person conducting the burning. (Note burn times on the permit.)

## Energy efficiency - proper insulation

One of the simplest ways to reduce your home's heating and cooling costs—and improve comfort—involves installing proper insulation. Doing so provides resistance to heat flow. The more heat flow resistance your insulation provides, the lower your heating and cooling costs.

Heat flows naturally from a warmer to a cooler space. In winter, heat moves directly from heated living spaces to adjacent unheated attics, garages, basements, and even outdoors. It can also travel indirectly through interior ceilings, walls, and floors—wherever there is a difference in temperature.

During the summer cooling season, the reverse takes place. Heat flows from the outdoors to the interior of a house.

To maintain comfort, heat lost in the winter must be replaced by your heating system. In summer, heat gained must be removed by your cooling system. Proper insulation, though, decreases heat flow.

Heat flow resistance is measured or rated in terms of its R-value. The higher the R-value, the greater the insulation's effectiveness.

When calculating the R-value of a multilayered installation, add R-values of individual layers. Installing more insulation in your home increases the R-value.

Insulation effectiveness also depends on how and where it's installed. For example, insulation that gets compressed will not provide its full rated R-value. The overall R-value of a wall or ceiling will be somewhat different from the R-value of the insulation because some heat flows around the insulation through studs and joists. Therefore, it's important to properly install your insulation to achieve the maximum R-value.

# Kayak Poker Paddle 2009

Nearly one hundred kayak paddlers and one canoe registered for the 2009 Poker Paddle at Kelleys Island State Park beach on the windy Saturday, September 19th morning. Most were somewhat anxious, wondering how Lake Erie would treat them that day. The wind was calm earlier, but by 8:30 the table cloth on the registration table needed to be weighted down, and the nor'easter sent white caps to the shore.

Pat and Lori Hayes, Jack Wade and Ranger Mike Monnett were deciding if it would be safe to direct kayakers to circumnavigate Kelleys clockwise, and finally announced at 9:40 that the rollers on the shallow eastside posed too much of a danger. After a brief discussion, the decision was made to direct the seafarers west to the lee of the island. My wife, Barb, sighed relief, and I, having yet to be humbled by 4 footers, was a touch disappointed that the circumnavigational challenge would need to wait for another year. Our first stop for our lucky card would be the old stone dock beach, then south and east to the beach by The Inn, further east to Lakeside Landing, and then retrace the route on the return trip to the Kelleys Island State Park beach.

Barb and I have a Hobie Tandem Kayak with a pedal drive system, and all of the marketing hype indicated that this was a fast kayak. Our boat looked like a pretty fat and heavy bath tub next to the other sleek long kayaks. Never being tested, I did not know how we would do. I kept reminding myself that this was not a race, and a leisurely pace would be acceptable, but still I did not want to come in last. I was not even sure that I could handle the 12 mile trip.

At 9:50 the starting signal sounded and the paddlers pushed off the beach and hit the waves. Not wanting to get

pushed into shore rounding the boat ramp breakwall, the smart kayaker respected the danger and took a wide path. I was falling behind, so we cut the corner. No problems. The following 3 to 4 foot seas pushed us around a little bit, but the Hobie was pretty stable. Nevertheless, I wondered what it would be like in a few hours when we would be hitting those waves bow-on.

We were glad to round the north-west corner, and found the relatively calm water of the protected west side. We were not glad that we were about the last boat to arrive. We beached and got our card, and a cookie – thanks Sari and Rob. I felt pretty good with my king, and Barb gloated over her ace. We were off to a good start. We hugged the shore until we rounded Carpenter's Point and were again hit by a head wind – what?? Did the wind shift to the southeast? At The Inn's beach, Lori was up to her knees in water directing the kayakers to paddle right up to her for their card; no need to beach. Barb's 3 and my 9 did nothing for our poker hands.

Another half hour paddle and we landed at Lakeshore Landing, where Caroline DeBoard gave Barb a 5 and me a 7 – not looking too good for the big prize. We had our snack and hit the rest rooms at the Seaway marina, and took off again – this time heading west with the wind. Only needing 5 cards, we skipped the return stop at The Inn, and continued around to the StoneDock beach. After receiving two cards that did nothing for our poker hands, we needed to decide whether to end the trip in the quiet of the lee of the island, or continue around to the State Park beach and fight the 4 footers head on. I told Barb that I thought the wind had shifted more to the South East, so it would not be as rough as a few hours



ago. She reluctantly agreed, against her better judgment, and we decided to continue on. When we rounded the corner, the waves were bigger than ever, especially when you were looking up at them from the low seat of our kayak. I was pretty white knuckled, fighting to overcome the waves. Barb was unusually quiet. We passed a boat that was trolling for fish and I was pleased to see Barb wave at them. She must be doing ok, then. It seemed like for every yard forward, the waves would push us 2 feet back. It took about 45 minutes of exhausting work to finally round the boat ramp corner and let the following seas push us into the State Park beach. At 1 PM, we high-fived each other and the other kayakers that already finished. Whew – what a rush. It turns out that Barb and I were in the first 25 that landed. Jack Wade gave us our last cards; Barb ended up with nothing except an ace high and I held a pair of nines.

Pat Hayes had hot dogs going, and the warm snack hit the spot. Over the next hour the rest of the kayakers landed, but we were worried about the canoe. Reports indicated that the canoe had checked in at the West Bay beach, and they had decided to continue on and tackle the wavy north shore. Scouts headed for the alvar and found the brave canoers about 50 yards off shore doing well, but going slow.

After snacks we gathered around to

figured out the prizes. The grand prize winner displayed a jack-high full house and was rewarded with a nice handheld GPS, and by the time a pair of nines hit the winner circle I was relegated to a pair of work gloves. Barb's ace high landed her 50 feet of light blue nylon rope. Almost everyone got a prize, so all were happy. The canoers showed up after the deciphering of the poker hands, so they were too late for prizes but instead got a nice round of applause. Surprisingly, they took on very little water and stayed pretty dry. After lingering around, the paddlers slowly said goodbye to new found friends, and Barb and I loaded our kayak, and headed downtown to a nice healthy Kelley's Island lunch and a couple of drafts. Then we napped.

The Poker Paddle was conceived by Pat and Lori Hayes and Jack Wade about 12 years ago as a way to promote the natural beauty of the shore that can only be enjoyed by a slow paddle around the island. The 2009 Poker Paddle was the 11th annual. Usually about 100 paddlers show up for the event, and some have paddled in all 11. The organizing committee is composed of Pat and Lori Hayes, Jack Wade, Mike Monnett, and Judy DuShane. All proceeds are returned to the event to purchase supplies and prizes for the following year.

During the late fall the island has transformed into a sports person's paradise, transitioning from kayaking and sailing to fishing, hunting and owl banding. Yes, owl banding! The Kelleys Island Audubon has been banding saw whet owls for 6 years now at the Scheele Preserve. Master Bird Bander, Tom Bartlett, has been studying the saw whet owls migratory habits and population trends. So far this season Tom has banded a total of 15 saw whet owls and 3 screech owls. So if you love the outdoors but are not a hunter or fisherman then come join us and watch owl banding. Dates are posted at the post office and it is determined on weather. On November 7th, Tom Bartlett was elected President of the Inland Bird Banding Association.

The Association comprises 15 central states and 2 Canadian provinces. Tom has been banding for 37 years. Congratulations Tom!

In other banding news, Tom has banded a total (so far) of 504 birds on Kelleys Island in 2009. He was trying to reach his goal of 500 and he made it! Bird Sightings are a popular agenda item at our meetings. Mergansers and Bufflehead ducks are now coming through on Lake Erie. Grebes and Bonaparte Gulls have also been reported, several eagles and loons have been seen at the State Park. Thousands of yellow and ruby crowned kinglets were migrating through the island in mid-October. What have you seen? The last pot luck and meeting of the season was held on

## Counselor's Corner

Dave Slosser, Kelleys Island School Guidance Counselor

Kelleys Island eleventh graders, Ty Bell and Michael Krzynowek joined approximately 3.5 million students that took the preliminary SAT/National Merit Scholarship Qualifying Test October 14th. The test was given by Mr. Dave Slosser, School Counselor. The SAT/NMSQT measures skills important for college success and provides students with the tools they need to start planning for the future. The PSAT/NMSQT measures the critical thinking skills students develop through years of study in a wide range of courses. It assesses students' ability to reason with facts and concepts rather than their ability to recall them. The test measures skills in three basic academic areas:

- **Critical Reading:** Assesses students' abilities to draw inferences, synthesize information, distinguish between main and supporting ideas, and understand vocabulary as it is used in context.
- **Mathematics:** Deals with number and operations; algebra and functions; geometry and measurement; and data analysis, statistics, and probability.
- **Writing Skills:** Measures the ability to identify appropriate expressions in Standard English, detect faults in usage and structure, choose effective revisions to sentences and paragraphs, and recognize appropriate writing strategies.

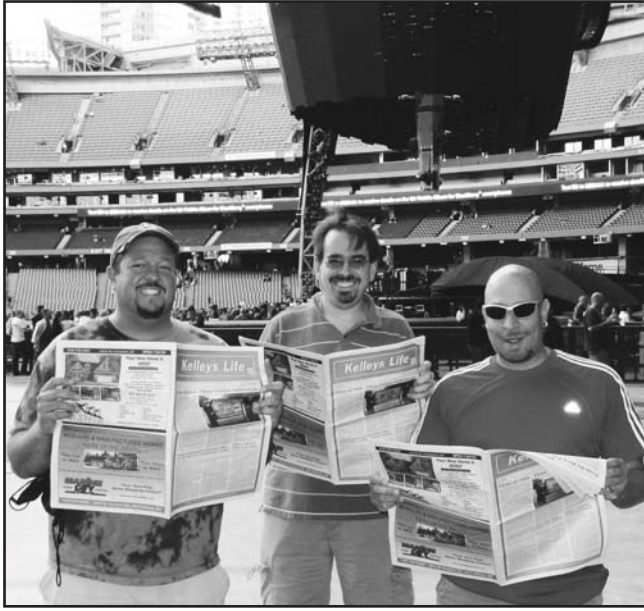

# Maybe we should all make lists... and check them twice

"He's making a list and checking it twice..." go the lyrics to a popular Christmas song. I wonder how many of us make lists this time of year? We might make a list of items needed to get us through the winter; or a list of gifts that are to be given. Maybe we have a list of "things to do" to get our house ready for the cold weather. Do any of us have a list of people we need to call or write? How about a list of books that we want to read? Anybody have a list of expenses for tax purposes? The types of lists are many but I wonder if there isn't a common thread - writing things down so we don't forget. Have we ever made a list and then forgotten where we put it? Lists serve a good purpose in giving us a device to remember. With the busy-ness of the season or our inability to remember everything, it may be good to have a

list or two. Let me suggest two lists that we can create.

The first list could be called a "life" list. Start by putting "breathe" on your list. Maybe we don't always think of breathing, but do we ever take breathing for granted? By recognizing every breath we take as another moment of life, we might be a little more grateful for that gift of life. Next, put "look" on your list. How many opportunities to help someone else do we miss because we are not looking? By reminding ourselves to look out for others, we may be there when someone needs us. Isn't that a better way to create community? On your list put "learn". What opportunities are there for us to learn? ## Ask Serving Our Seniors

*Serving Our Seniors is a local, not-for-profit organization funded by the Erie County Senior Services Tax Levy. Serving Our Seniors is a geriatric social service agency that provides a variety of help to Erie County residents age 60 and better. The organization's purpose is to assist older people in maintaining their independent lifestyle.*

### Memory Screening: It's Not A Diagnosis, But It's Worth Your Time

Every year the Alzheimer's Foundation of America holds a National Day for Memory Screening. Serving Our Seniors was set to provide a Memory Screening on Kelleys Island on November 17th from 11 am - 2pm at St. Michaels. Because of weather conditions, the ferry service was unable to dock and this prevented Serving Our Seniors from providing the free Memory Screening services to Kelleys Island residents.

Before I go any further, let me explain what is a Memory Screening - and what it is NOT. A memory screening consists of a series of questions that are asked, in private, in an environment that does not have distractions. The questions are simple in nature and used to detect if there is a problem with memory, the ability to recall information, the ability to organize thoughts and the ability to think in abstract terms.

A memory screening is not a conclusive diagnosis and it does not replace the need for consulting with a qualified health care professional if you do have concerns about your memory and your brain's ability to process information. But it is helpful information for your health care professional to use as they work to identify the cause of any cognitive deficits.

### Who should have a memory screening?

The Alzheimer's Association of America recommends a memory screening for anyone. It's a great for those who do not have a concern right

now, but who wants to see how their memory is now for future memory screening comparisons. Memory screenings are also appropriate for people who do have concerns about memory loss, their ability to concentrate, and/or decline in their desire to do things that they use to like to do.

### Why is a Memory Screening worth my time?

Unfortunately, too many people assume if they have memory impairment it must be that incurable disease known as Alzheimer's Disease. This is not true. There are some forms of memory impairment that are treatable - if detected in time and are properly diagnosed. Some examples of reversible memory impairment are: Vitamin B deficiency, urinary tract infections, depression, and medication interactions. But if the patient does not know that forms of memory impairment can be treated and the person will usually choose not to seek the attention their memory problem deserves. A memory screening may be the impetus they need to understand memory impairment and its treatment.

### When will the next memory screening take place on Kelleys Island?

Serving Our Seniors is in the process of arranging another date for the Memory Screening Day. The specific date, time & place still needs to be worked out. We will stay in touch with Dot Simonds to help get the word out to you. You are also invited to register for the Kelleys Island Memory Screening Day by calling Serving Our Seniors at 419-624-1856. 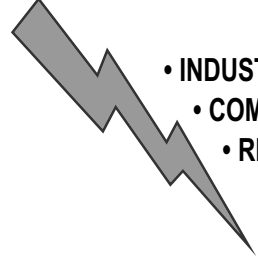

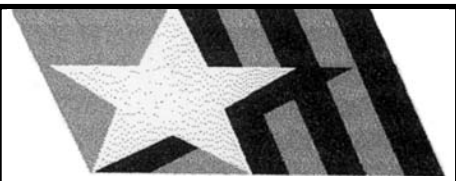

The lives that passed out of ours and beyond this shocked and grieving community during the last weeks of October touched all of us. In one way or another—some more deeply and personally—all of us mourned these public figures whose now-absent con-

tributions to the fabric of 'community' leave scars and fractures as we face our public and private futures. Who can fly into the airport, attend a school function, consider a building renovation or more major project, or read this newspaper without reflecting, recollecting the public service



contributed by one of 'our' own, now absent from our daily island busyness?

Their passings—coming in a wave of disbelief—shocked and saddened us all, leaving repercussions like tsunami waves of grief, bright moments of remembered joy and richness, struggling to overcome the extremes of living. And the public respects paid to their passings could-

n't have been more different. A formal church rite of passage marked with age-old prayers and rituals followed by yacht club meal (I can see his wry smile and suspect which he preferred!). A gravesite remembrance of the life that passed by too quickly, framed by song, as crowds pressed closer together, huddling against a sudden sharp wind and spitting rain in a cloud darkening cemetery. And a celebration on a clear bright sunny afternoon as the sun started to set against a strange appearance of a huge cross in the sky formed from intersecting contrails. A last spirited touch to the joy of remembering and the pain of absence from these friends.

# Learn And Serve Challenge

After the tour, everyone then went to lunch where the students listened to the last speaker that was a guy who was the head of a volunteer program in Ohio called Americorps. He talked about what Americorps did

and some information about the program. After the speakers, everyone gathered back into their groups to give a little presentation to everyone else on what they did. These presentations ranged from skits, to videos and songs. After that, we then were dismissed and everyone headed back home.

Going to the Learn and Serve Challenge was a great experience. We now can bring back things we learned from there and help out our community. Whether that is cleaning up litter left around the island our volunteering


the school. The collection pile has already begun!

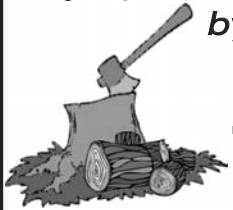

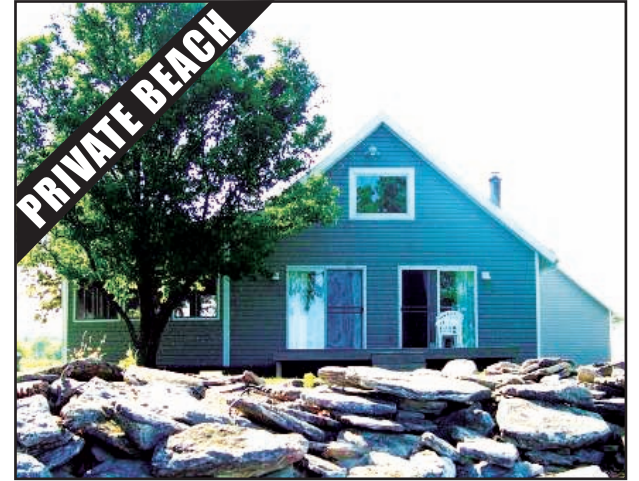
