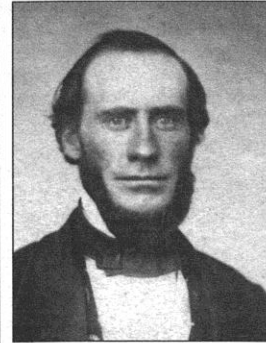
Anne to buy the units.

William S. Webb family donates Civil War correspondence—

An ongoing series of the KIHA Newsletter

Through the generosity of family members of **William S. Webb**, we were given transcripts of letters that Mr. Webb wrote to his family during his 100 days service in *The Civil War*. Since the Kelleys Island men left as a company from the island, they, initially at least, stayed together and thus Mr. Webb's letters sometimes include mention of other islanders who were also fighting. It is not often that a person has the opportunity to relive history.

William S. Webb was married to **Elizabeth Kelley** and three children—**Sarah, Isabelle and Charles**. In 1860, William S. Webb is listed on the Census as a stone mason earning \$8,000 a year.

William S. Webb went to war in 1864 and he wrote letters home to his family on Kelleys Island. Captain Webb's daughter Sarah copied his letters into a notebook. **William D. Webb** is the great-grandson of this Kelleys Island Civil War soldier and his grand-daughter, **Katia Duey**, transcribed the letters from the notebook. Katia Duey is currently attending Temple University. We sincerely thank the William D. Webb family for their interest in their own family history and that of Kelleys Island—and for the opportunity they have given the Kelleys Island Historical Association to share this wonderful story.

William S. Webb was first stationed at **Johnson's Island in Sandusky Bay**, along with other Kelleys Island soldiers. (Added information will appear in [] .)
Point of Rocks Virginia, June 28, 1864 (continued from our Summer issue)

Deserters are coming in all the time and we of the Picket Guard are about as much on the watch for these as for the pickets of the "Rebs" and we have instructions to be very careful not to fire on them. I had a conversation with a Capt. of the 3rd Virginia who came in day before yesterday. He had only 15 men left of his company and said they would all be in that night if they could get through the lines. There was a squad came in that night whether his men or not I did not learn. From the cloud of dust yesterday morning at Petersburg it is supposed that the Rebs were leaving there. A deserter who came in also reported that many were leaving but that they are evacuating, I do not believe.

The Chaplain informed me yesterday that he saw an article in some paper in which **Gov. Brough** (Ohio's Gov.) stated that the O.N.G.'s (Ohio National Guard) here ought not to have been sent here, that no such disposition of them was intended by himself, and that the President stated in reply that it was done without his knowledge. The Chaplain also says he saw in the *Cincinnati Gazette* a statement that Gov. Brough had perfected arrangements by which the time of the "100-day men" was to be counted from the 2nd of May, that is that our time was to be up in 100 days from that date. I hope that is the case. Not a Reg't, not an Officer, not a private that I know of, but that considers it a breach of good faith on the part of someone. The effects of it will be very apparent in the fall election, especially if kept over their time.

Whenever you see any statement of and reg't of O.N.G.'s having "volunteered to go to the front" you may without any fear of contradiction set it down as false, wickedly false: they all volunteered as we did, knew nothing about it until we got our orders. We heard the 132nd and 134th had volunteered

also. They are both now in our Brigade and preceded us here, both almost mutinied at being sent here and their short period of service left for which the O.N.G.'s were called out is all that has kept down a more tangible show of insubordination. All are pretty well quieted now as their term of service shortens, and those reports of counting our time from the 2nd of May, or of our being discharged in 90 days from that time...all have the effects of allaying or modifying expressions of feeling on the subject. As for myself I intend to the utmost of my ability to do my duty and if my Country is benefitted by my services I shall be thankful that I have to the extent of my opportunity been enabled to render those services, but shall in common with my fellow soldiers reserve the right of calling to account at the proper time anyone who may endeavor to place me in a false position.

In a conversation with the Chaplain the other day in relation to the report that we had volunteered to show the effects of the report at home I handed him your letter written after you had just heard it, he read a part of it referring to that subject and handing me the letter remarked, "the man who has such a wife as that has a fortune," and the big tears followed each other down his cheeks as he turned his head the other way, his eyes were not the only ones from which the involuntary tear started at that moment, nor was his the only tongue that was incapable of giving utterance to the thoughts that caused those tears. Poor fellow! He had not received a line from his wife since leaving **Johnson's Island**.

...I have just gone along the picket line occupied by my boys and find most of them enjoying a good sound snooze except the one man at each rifle pit who is on duty. It is growing quite warm as the sun approaches the meridian but a fine breeze is rustling among the leaves of our shelter shanties, and all are enjoying it and glad to be out of the smoke, dust, and heat of the camp. **Jerry's** health is being improved by the campaign. **Lester, Dan**, in fact all of the boys are well, only disappointed that our letters from here had not reached their friends.

I rec'd a letter from **Sister Caroline**, tell her I thank her for her kind consideration and will endeavor to repay her, my letters are for all who wish to hear from me, and I endeavor to write such information as may be of interest to all. In writing for all I cannot go into details as others can and if my letters seem too general in their tone you must attribute it to the right cause. It is my purpose and constant endeavor to take every possible care of the health of my command, and if I can relieve the feelings of their friends at home by keeping them informed of the situation here I also consider it my duty to do so.

When the Reg't marched on that fatigue expedition there were only 9 men left in my Co. (including the cooks and Jerry

whom I had detailed as Co. Clerk with me) who did not consider themselves fit to go, while other companies, but a few men stronger, had from 17 to 21 left. The Colonel complimented me on the fact. I gave **Geo. Bookerman** a draft on **Alfred** (Kelley) for \$5 which he wished to send to his wife, see her or Alfred and explain to her, or have him, that she can draw the money at the store by presenting the draft. **George** may not explain it to her.

I wrote the other day to **Sarah, Belle and Charlie** each separately. I hope those letters will come to hand safely. I wrote you the day before I wrote them and I think they after but have forgotten the dates. There is a rumor in camp that we are to be relieved by the 18th Corps soon, and if that is so we shall be moved to **City Point** 4 miles from here, at the junction of the **James and Appomattox Rivers**, or to **Harrison's Landing** 25 miles down the river. I do not credit the report.

The opinion is entirely prevalent throughout the Brigade that our 100 days is to be counted from May 2nd and that we shall start from here time enough to reach home and be mustered out within the 100 days, this, if true, will shorten up our figures previously made by 13 or 14 days. I hope it may be so.

For the past two days the Rebel Battery which was throwing shot so persistently at our signal station has not fired a gun, probably having become disgusted at their want of success. It has done no damage except to kill one mule in our works and make one hole in the roof of a house through which one of the shot passed. Have just returned from the rifle pit occupied by **Morris, Dan, Oscar, Titus and Capers**, where I was handed a "company letter," it consisted of letters from several of the girls at home to the boys of **Holbrook's Sunday School**. Among other items of interest to myself was the fact that "Sarah will be at home next Friday," she is doubtless there now. **Alida** says to "spend the rest of the summer." This will render home less lonely during my absence. I find that it has been as dry in Kelley's Island as Bermuda Hundred. It has made two attempts to rain within the last 48 hours but failed each time. I shall very anxiously expect to receive letters from home by the next mail announcing the reception of letters from "Co. K" since we arrived at Bermuda Hundred.

Henry Ohlamaker had a very narrow escape by accidental discharge of gun which fell from the stack, fortunately he was not at all injured. These lessons will teach us all to be careful. I have written as long as my eyes will allow and must close this epistle. Do my letters seem too long? I can hardly write less, still I feel that I hardly say enough in substance whatever I may accomplish in the quantity of words. Tell **Emeline** that **Dan** is first rate, also the same to **Caroline** for **Lester**. Tell "**Zina**," **Sarah Mitchell** and **Belle Dean** that their husbands are still well and in good spirits. Tell **Alfred** not to pay anything more on Real Estate indebtedness at present. Write as heretofore every other day at least, number your letters. My best respects to "everybody." Tell **Nellie** I have not forgotten her and hope to be soon able to sit down to one of her nicely cooked dinners. My best respects to **Susan** and **John** and all my men. Our picket is taking dinner now.

A Kelleys Island memory...Jake the navigator

In July, 1944, I was able to take a leave from my Navy training in Boston, and decided to visit my mother on Kelleys Island. Dad was in France with the 9th Air Force at the time.

After months of Navy chow, I was ready for Mom's home cooking! The train arrived in Cleveland at about midnight, after the long ride from Boston. My buddy's father met us at the station and took me to Rt 2, at the west end of Rocky River, where I started hitch hiking at about 1 AM. Traffic was pretty light, with gas and tire rationing in effect, but I finally got picked up. Things were great until we ran into fog off the lake. At times it was so thick I ran along the side of the road with my white hat waving to keep the driver on the pavement. No edge lines then!

We pulled into Sandusky about 6 a.m., and the kind driver delivered me to **Neuman's Dock**. About 6:30, **Jake**, skipper of the **Mascot**, showed up. After explaining that I was waiting for the 8 AM boat to Kelleys, Jake said I might as well keep him company in the wheelhouse.

At that time, Neuman had a contract to haul workers to a site on **Cedar Point**, leaving at 7 a.m. The fog was still very thick when 7 a.m. arrived, but Jake didn't seem to mind. "I can't see very far anyhow," said Jake, who wore rather thick glasses, so he navigated by compass and time. We chugged slowly out and over to the Cedar Point shore, seeing nothing but fog all the way.

"I think we're there," said Jake, who stopped the engine, and gave a short whistle blast. A voice from the fog said "over here about 200 feet," so Jake backed up, and came in again about 200 feet to port, right at the dock!

We waited there for about a half hour after unloading the workers, and suddenly the fog lifted. The trip back to the Neuman Dock, and then on to Kelleys was uneventful, but riding the **Mascot** was always an adventure. Jake certainly gave me a fine lesson in dead reckoning navigation that morning!

I have spoken with several long time Islanders who remember Jake very well, and many of you have your own "Jake the Navigator" stories, or other similar adventures.
