Throw The Bums Out?

No, no this is not about the Mayor and Council. But in spite of the prevailing attitude in the country, it will be difficult to be anti-incumbent in the November election for Erie County officials. Candidates for seven of the ten offices up for election are running unopposed. Prosecutor Kevin Baxter, Common Pleas Clerk Barbara Johnson, Sheriff John Magnuson, County Recorder John Schaeffer, Treasurer Beverly Pressler, Engineer Ed Feick and Judge Ann Maschari have only write in candidates to worry about in their reelection bids.

Two of the contested races are seats for the County Commission to be selected in two different contests. One pits Harold Butcher against Natalie Mosher while the other has Thomas Ferrell and Jeffery Krabill vying for the job.

The third contest involves the position of Coroner and has Joseph Buder and Thomas Nesgoda running for the spot.

On the State level, local voters will help select a member of the State Board of Education from a slate of five: Jim Bishop, Robert Brown, Carolyn Eyre, John Schulte and Martha Wise.

Also on the ballot for State offices are the State Senator position (John Hartman vs. Betty Montgomery) and State Representative (George Mylander vs. Darrell Opfer). The State Supreme Court contest involves selection of the Chief Justice (Robert Gorman, J. Ross Haffey and Thomas Moyer) and two Justice races (Mark Painter vs. Francis Sweeney and John Patton vs. Paul Pfeifer.)

At the Federal Level, Michael Dewine, John Glenn, and Martha Grevatt are running for one of the Senate seats from Ohio. Paul Gilmore is unopposed in his 5th district Congressional election, and two members of the 6th Circuit Court of Appeals are also running unopposed (Charles Abood, George Glasser)

And, finally, in the race for the Presidency, Island voters will have more choices for that they had in the last mayoral election. Besides the Bush/Quayle, Clinton/Gore and Perot/Stockdale combinations, voters will also be tantalized by the candidacies of Fulani/Munoz, Gritz/Minett, Hagelin/Tompkins, LaRouche/Bevel and Marrou/Lord.

EIGHT ISSUES ON BALLOT

The voters of Kelleys Island will have eight issues to decide on when they go to the polls or submit absentee ballots on November 3. A check with the Erie County Board of Elections

"It's In Litigation"

On the surface, or in public, little has happened with regard to the Martin lawsuit and the duplex on Woodford Rd. The stock answer to queries on the matter has been "It's in litigation" and use that as a shield to deflect discussion.

Zoning Inspector Jack Terry though will make at least one further statement. He says "It's in litigation, but why does he have us in court and not the other way around."

Terry candidly admits that he has not issued a citation for the structure, which was erected without a zoning permit. He has attached notices of Violations to the structure, but Terry has not issued a citation because he has not received any indications that its prosecution would be vigorously pursued. He reasons it would be futile to issue a citation and have it defeated because of lack of zeal in its prosecution.

Indeed the Village Solicitor has refused to be involved in the prosecution of any actions against Village Council members, citing a conflict of interest (currently two other Council members have court actions pending).

On the other side of the fence, the Martin lawsuit has clearly captured the attention of the rest of the Councilmen. An executive session before the regular Council meeting resulted in the passage of a resolution to seek a second opinion about the lawsuit from a trio of outside law firms (although it took a hastily called second executive session to secure the necessary understanding to pass the resolution). There is also the not-so-well kept secret of an attempted trade of dropping prosecution of Curilla for acquiescing to Martin's demands. Obviously, that has not happened.

Ted Terry, Jack's bother, has also joined the fray with a petition demanding the laws of the Island be enforced.

The petition, signed by over a hundred residents according to Terry, was read at the October Council meeting. Its body reads as follows:

We the undersigned are residents and taxpayers of Kelleys Island. We formally demand that the Mayor, Council, Police Chief, and Zoning Inspector enforce the laws of Kelleys Island in a uniform and equitable manner. Specifically, we are concerned that Charles Martin has erected a house apparently without a valid building permit. If no building permit was issued, and this building is allowed to continue to exist, then there would appear to be an uneven enforcement of the law.

We hereby demand that the Mayor, Council, and other enforcement officers take all appropriate legal action to enforce the law in this regard. We will expect that such action will be taken forthwith. If it is not, then we will have to assume that no action will be undertaken and will authorize proceedings on our behalf in accordance with all remedies available to us. We trust that you, our elected officials, will uphold your oaths and do your duty pursuant to law.

Public Hearing On Shoreline Zoning Map, Text Modification Scheduled

A public hearing has been scheduled for 1:00 on November 27, 1992. That date is the Friday after Thanksgiving.

The meeting will be to receive public comment on two items: the new shoreline zoning changes to the zoning map, and an amendment to the text of the zoning ordinance.

The proposed map, which is the definitive document for the zoning of property, contains additions of zoning classifications for the shoreline. The classifications and map delineation's are: Commercial Marina, Commercial Port, Industrial Port, Private Facilities, and Semi-private facilities.

The proposed textual change to the zoning code will create controls on the building of structures on shore protection facilities, such as jetties, breakwaters, etc. The proposed change will add a new section, 1601-6(h)(3) and will read as follows:

It shall be prohibited to build, erect, maintain or establish any type of structure or building on any shoreline protection structure in any shoreline zoning district. In addition, it shall be prohibited to conduct, maintain or establish any business on any shoreline protection structure in any shoreline zoning district.

In a related issue concerning the shoreline, the Ohio Department of Natural Resources has announce renewed efforts to secure submerged land leases for all structures in the Lake. They have already moved to get all structures on Johnson's Island into leases, and have announced the Bass Island will be their next target. Is there a pattern here? Conquer the Islands first?

Continued From Page 1 indicated they were "swamped" and couldn't even promise when

they might be able to provide a count of absentee ballots and registered voters until after the election.

Only two of the eight issues are Island specific and both cover tax levy renewals. The wording of the Island related issues as they will appear on the ballot are as follows.

ITEM 23

A Majority Affirmative Vote is necessary for Passage

A renewal of a tax for the benefit of Kelleys Island Village, Erie County, Ohio, for the purpose of CURRENT OPERATING EXPENSES at a rate not exceeding five (5) mills for each one dollar of valuation which amounts to fifty cents (\$.50) for each one hundred dollars of valuation for 3 years, commencing with the tax duplicate years for 1993, 1994 and 1995.

ITEM 24

A Majority Affirmative Vote is necessary for Passage

A renewal of a tax for the benefit of Kelleys Island Village, Erie County, Ohio, for the purpose of PROVIDING FOR ADDITIONAL FUNDS FOR EMERGENCY MEDICAL SERVICES at a rate not exceeding one and five-tenths (1.5) mills for each one dollar of valuation, which amounts to fifteen cents (\$0.15) for each one hundred dollars of valuation for the years of 1993, 1994, 1995, 1996, and 1997, commencing with the 1993 tax duplicate.


Other issues on the ballot are Item 1 which is a vote on whether to call a constitutional convention. This issue is required to be put on the ballot every 20 years.

The next three items ask voters to decide if term limitations should be imposed on Ohio political office holders. Item 2 seeks to limit Federal Congressional members from Ohio to 12 consecutive years in the Senate and eight years for holders of seats in the House of Representatives.

Item 3 intends to limit State Senators and State Representatives to eight consecutive years. Item 4 would limit elected members of the executive branch of the State Government to eight consecutive years. Included in the listed offices are the Lieutenant Governor, Secretary of State, Treasurer of State, Attorney General and State Auditor.

Item 5 is the controversial product labeling and business tax proposal. It will require warnings in conjuction with products containing substances determined to increase the risk of cancer or reporductive defects in animals or humans.

Mayor Haas, in spite of a recalcitrant Council, exercised his right to make unilateral appointments to the Planning Commission. He appointed Ralph D. Wilms to the a position which has been vacant since Ramie Dick resigned in August. Mayor Haas said he was asking for Council's approbation of the nomination as a courtesy.

Yoscovits objected to voting for Wilms because he doesn't know him, and because he has never "seen him at any Planning Commission meetings. I have never seen him at any review board meetings, (or) zoning meetings."

Herndon, who is Chairman of the Planning Commission, echoed Yoscovits sentiments saying "This guy may be a really good guy, but I cant vote for him either - I don't know the guy." It's a shame when somebody from the Village wants to volunteer their time - there is no money involved in the Planning Commission - and they have to come up here on their own in the winter months to attend meetings ... I don't think they should be subject to ridicule as Ralph has since the last Council meeting... I'm talking about what went into the Perchie Press about his A-frame home and "Ralph who? and

Draft Noise Ordinance Considered

A draft resolution of a noise ordinance for the Village was given to the Council for their consideration at the October 15 meeting by Solicitor Strickler. The intent of the ordinance is to set limits on the intensity of noise created by vehicles in and around the Island.

The draft ordinance will make it illegal for vehicles on a public right-of-way or private property to exceed a maximum sound pressure of 84 decibels at 50 feet for "speeds under 35 miles per hour or 90 decibels for speeds over 35 miles per hour" (of course the maximum speed permitted on the Island is 25 mph).

The draft ordinance will also seek to control noise from water craft operating within the Village harbor line. This limit will again be 84 decibels at 50 feet but that limit will be reduced to a level of 80 decibel for the hours from 10 PM to 6 AM.

The enforcement of noise ordinances generally require the use of a suitable sound meter. Enforcing the noise limit on the lake would also require the permission from the Ohio Division of Watercraft (and an enforcement boat would help).

Because of the need for quantitative measurements to make the ordinance more enforceable, most people have no idea of what level of noise the ordinance would regulate because they don't know what a "decibel" is or how loud a 80-90 decibels noise level really is.

A decibel is a unit of sound intensity named in honor of Alexander Graham Bell (its original definition proved too large, hence the use of "deci" or 1/10 bels). It is a logarithmic measure just the same as the Richter scale used for earthquakes. That means that each whole number on the scale is 10 times more intense than the previous number. Just as an earthquake with a magnitude of 7 on the Richter scale is 10 times more powerful that one of 6, so a sound intensity of 90 decibels (9 bels) is 10 the times the intensity of 80 decibels (8 bels).

Thus the proposed ordinance is not drawing as small a difference mathematically between the daytime permissible boat noise intensity of 84 versus nighttime level of 80 as it might seem, since the 84 decibels is 4 times as intense as 80 decibels. However, loudness as percieved by humans seems to be proportional to the logarithm of the intensity, so the difference of perceived loudness tends to be closer to the 5 % difference the decibels indicate. All of this is why the use of a sound measuring device is necessary

But still the question of how loud 80 decibels really is lingers on. To put that in perspective, the following representative intensity ranges for familiar sounds are given. Remember that the levels quoted for the following devices would be their intensity measured at the distance of normal use - not the 50 feet specified in the ordinance. Noise Intensity of a Food Blender 60-80; Garbage Disposal 65-90; Symphony Concert 80-110; Lawn Mower 80-95; Rock Concert 100-115; Shooting 118-125. It's a good thing the ordinance only applies to boats and vehicles or else there would be no more Brandy Alexanders at the Pump or Turkey Shoots at the VFW, and all garbage would have to go to the Transfer Station. On the brighter side, though, it would mean the end to lawn mowing and rock concerts...

The interest in the noise ordinance has been fueled primarily by boat noise, with the boat "Jaws" used as the prime culprit. However at the Council meeting Dennis Komiski stated that during the recent rash of complaints about Jaws, the boat was in Grand Rapids, MI getting engine work done.

Shannon Way Now Goes That'a way

The Village Council recently vacated the use of Shannon Way as a public road. Shannon Way was the access to the airport and the Celeste property off of Monagan Rd. The intent of the abandonment of public road use, was to eliminate the need for vehicles to cross the north/south runway.

Instead, a new easement for access to the Celeste property will be granted off of Lincoln Rd. east of the runway. The plane tiedown area will be moved to the west side of the runway.

The Mayor's suggestion that the new road be named Cardinal Drive was changed by Council to Shannon Road which will connect to Shannon Way.

Substantial Zoning Changes Studied

The Planning Commission is considering massive and sweeping changes to the Ordinance 303, which is the zoning ordinance. The proposed changes are being prepared by Poggemeyer Design Group of Bowling Green under a \$7000 grant to the Village. The changes are intended to make many sundry changes to the Ordinance as well as strive to implement some of the recommendations made in the Master Plan adopted earlier this year. The Port Master Plan was also prepared by Poggemeyer.

To date, several large packages of modifications have been given to the Planning Commission. Because of the volume and preliminary nature of the changes, they will be presented in detail by the Perchie Press as they are refined.

There is another special meeting of the Planning Commission on October 31 to consider more changes. The public is encouraged to attend.

Road Work To Start

Tar and chipping of four or five Island road should begin in the next several weeks. The exact roads have not been determined but the likely candidates would be Monagan from Woodford to Hamilton, Hamilton/Ward from Division to Monagan, Woodford from Addison to Monagan, Addison and possible Chappel St. The selection of the roads depends upon the amount of work that can be done with the available funds.

Lee Shadle, Streets and Sidewalks Chairman, said that Village workers have been preparing the roads for the tar and chipping operation. They have been attempting to fill in ruts, holes and low spots in likely candidates for work. This, Shadle indicated, is because the tar and chip coverage will not cure those blemishes since it is a surface coating operation and will not materially alter the contour of the underlying roadway.

The work will be done by Erie Blacktop.

Shadle also indicated engineers had been on the Island to assess the conditions of East Lakeshore Dr. in preparation for its repaying. This will, he said, most likely will be done in the Spring with Issue II funds.

Trees Can Bring A Tax Break

In late September, Bev Johnson of completed several days of training with the Ohio COVERTS project seminar in Jackson, Oh. She was one of 40 participants who learned ways to improve wildlife habitat through good forest management. The seminar was funded by the Ruffed Grouse Society and coordinated by the Ohio Cooperative Extension Service.

The seminar included indoor and outdoor sessions in ecology, forest and wildlife management. Bev states that of the 7.1 million acres of forest land in Ohio, 90% is privately owned and 50% of that consists of small woodlots. Suprisingly, an owner of 5 acres or more of woodland is eligible for a 50% property tax decrease. Bev would like to share the knowledge she gained from the seminar with the members of the community. She learned that the woodlands are one of our most valuable natural resources and provide valuable benefits for our environment and quality of life. Bev will be happy to pass on information on resources and encourages all to support "Treesource," a federally funded program initiated by Governor Voinovich committed to planting an nurturing trees across the State.

Step On A Crack, Break The General Fund's Back

The suit filed by approximately forty individuals against the Village over the installation of the new sidewalks in 1988 was settled in late August. The case was settled through a negotiated arrangement between representatives of the plaintiffs and attorneys for the Village. The agreement was accepted by Judge Ann Maschari on August 26.

The order from the courts said the original assessments for parcels where sidewalks were installed were "in excess of the benefits conferred upon such parcel" and that relief was due to the all property owners who were assessed, not just those who were a party to the suit.

The original assessments totaled \$263,961 exclusive of the amount assessed to the ODNR which was the subject of an earlier negotiated settlement. The agreement reduces these assessment by 26.5% or \$69,950. This reduction in bills to the affected property owners will be passed on to those that paid the assessments up front as a refund. Those that elected to have the amount collected over 10 years as additional taxes, will have the remaining seven uncollected payments reduced by an amount that will give the 26.5% benefit.

The agreement further stipulates "that the costs of this action shall be assessed against the Village and further orders the Village to pay to the attorneys for the Plaintiffs their attorney fees in the amount of Fifteen Thousand and 00/100 Dollars (\$15,000)." That, of course, is in addition to the fees accrued by the Village on its own behalf. The negotiations were handled by Village Solicitor Strickler with help from former Village Solicitor M. L. McDermond as special counsel.

The original cost of the sidewalk installation was financed on a note held by 3rd National Bank of Sandusky. Revenues from the assessments were to be used to amortize the note. Any additional moneys needed to cover the cost of repaying this debt, in excess of the fund amount, will come from the general fund.
