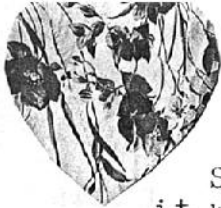

Griffing Airlines round trip to Kelleys is remaining the same price of \$25.00 plus 50¢ per grocery bag.

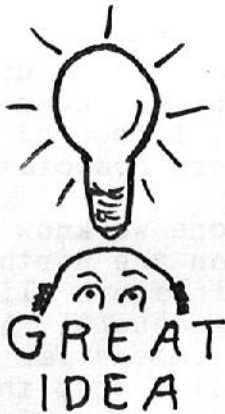

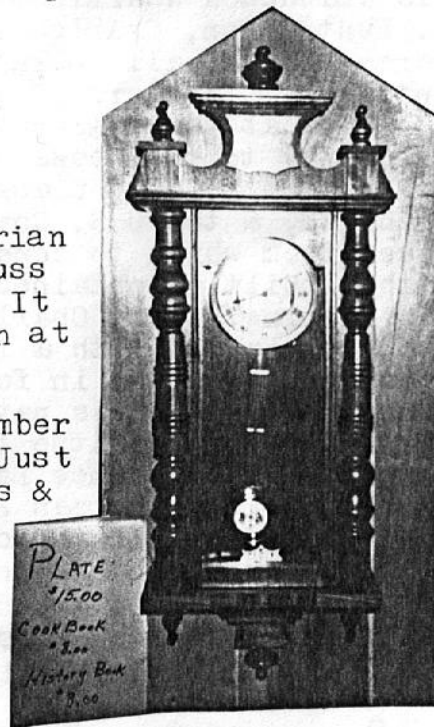

### Early Quarry Operations

With all of the quarrying activities now in progress on Kelleys Island & with the newer boat lines coming into the docks here, I thought it appropriate to mention early settlers associated with the quarries & boats.

John Clemons was the first one we know of who opened a quarry here. This was on the north side of the island where there is a miniature cliff & where there is deep water just off-shore. A dock for loading stone didn't need to extend far into the lake. It was from this location that the Kelley brothers shipped stone & cedar. In spite of fierce north winds, the dock stayed in place for many years. After 1835, the quarry was abandoned & the property was sold to Calkins & Company in 1872.

In 1842, John Titus opened a quarry near the shore of West Bay & built a dock for shipping stone. George Kelley opened several small quarries. The pond across from the Old Stone Church was one of his abandoned quarries. William S. Webb, George C. Huntington, Charles Carpenter, & Franklin & Norman Kelley all operated quarries from the 1850's until near the turn of the century.

The above mentioned people built docks & even a railway to the docks to ship their stone. They sent stone to many places including Cleveland, Michigan, & the U.S. Government. They built offices from which to conduct their business, & they either built or obtained boats, scows, & schooners for hauling. Once Charles Carpenter's scow Elmina left the island with a load of stone headed for Cleveland. Fog set in for two days, & evidently the captain lost his navigational skills or judgment, because when the fog cleared, he discovered that he was in Maumee Bay nine miles from Toledo.

Franklin & Norman Kelley, brothers of George Kelley, began serious acquisition of quarries in 1865. They purchased interests from Webb, Huntington, & brother George. Then in 1869, Norman purchased all of Franklin's interest. He made a contract with Cleveland Rolling Mill Company to supply



it with flux stone for use in pig iron furnaces. Demand for flux stone as well as Kelleys Island limestone continued to increase.

G.W. Calkins & Company along with M.C. Younglove & Charles Hickox acquired land on the North Bay & Long Point. They built a new dock erected lime kilns, & had a cooper shop for making barrels in which to ship lime. They built tenements & boarding houses for their employees. They had a steam barge christened the Charles Hickox built at Lorain, Ohio. They quarried stone for use in building the first large American lock at Saulte Ste Marie (The Soo).

For a short time a company called the Kelley Island Quarry & Lime Company, the Huron Lime Company, & the Superior Manufacturing Company had interests in stone land on the island. Beginning in 1891, the Kelleys Island Lime & Transport Co. acquired most of the quarries. It was a large company with holdings in many places which eventually overshadowed their interests here.

Because the history of our quarries has been an "open & shut" book from its beginning, we'll use space in another issue for bringing us up-to-date on what has happened since the late 1800's to the present day.

Having a quarry in operation again is an exciting experience for those who live on the island. It not only means more people during the long winters but also more revenue for those who struggle to keep their businesses open. I'm sure that was true for our early settlers also.

## Turkey Pot Roast

|---------------------------|----------------------------------|
| 4 turkey drumsticks       | 1 lb. mushrooms,                 |
| Vegetable oil for coating | sliced                           |
| Salt to taste             | $\frac{1}{2}$ cup dry white wine |
| Pepper to taste           | 1 tablesp. dried                 |
| 1 tablesp. vegetable oil  | tarragon leaves                  |
| for sauteeing             | (or 2 tablesp.                   |
| 1 cup chopped onions      | fresh tarragon,                  |
| 2 garlic cloves, minced   | chopped)                         |
| 1 can (28 oz.) tomatoes,  |                                  |
| drained & chopped         |                                  |

Rub drumsticks all over with oil then sprinkle with salt & pepper. Broil drumsticks, turning until completely browned; set aside. Heat oil in a Dutch oven or large skillet & saute onions & garlic until clear. Add mushrooms & saute, stirring occasionally, for 5 to 6 minutes more. Add wine, tarragon & tomatoes, stirring to blend. Add browned drumsticks, cover & cook on medium-low heat, stirring occasionally, for about 1 hour or until tender.

# Jeannette Cleary, 91, rights activist was Michigan's 'Eleanor Roosevelt'

A champion of human rights who left imprints on Detroit and other parts of the nation, Jeannette Cleary, 91, of Highland Park died Tuesday, Sept. 18, 1990, in St. Vincent Hospital, Toledo.

Mrs. Cleary died from complications of injuries suffered in a fall in her Kelley's Island, Ohio, residence.

She was involved in a number of causes over the years, but perhaps was known best for helping spearhead observance of the Universal Declaration of Human Rights on Dec. 10, 1948, in Detroit.

As a result, said James Bush, longtime staffer in the City of Detroit Human Rights Department,

Detroit is the only urban area to mark the anniversary each year.

"She was Michigan's Eleanor Roosevelt," Bush said. "After the United Nations adopted a resolution in 1948 that led to many of the human rights covenants of today, she worked hard through the Women's International League on Peace and Freedom to see that Detroit observed it."

Mrs. Cleary received the United Nations Silver Scroll commemorating the 25th anniversary of the observance, said a daughter, Anne Sennish.

Mrs. Cleary also helped register minority voters in the South in the 1960s, and was part of the civil rights march on Selma, Ala.

In 1988, she received the

Women's Equality Day Award from the City of Detroit's Human Rights Department.

"That was for her dedication and deep commitment to women's, children's and men's rights, everyone's rights," Bush said.

Mrs. Cleary was the grand marshal of the Kelley's Island Homecoming Parade last August. She was born and reared at Kelley's Island in Lake Erie.

Surviving besides the daughter are her husband, George; another daughter, Caroline De Bord; nine grandchildren and four great-grandchildren.

A memorial service will be at 2 p.m. Oct. 23 in Central United Methodist Church, Woodward and Adams, Detroit.

Ordinance No. 539 then declared passed.

Motion to declare Ordinance No. 540 (providing for retaining Squire, Sanders & Dempsey/certain Legal Services for Waterworks System First Mortgage Revenue Bonds, Series A & B) an emergency, set aside rules & advance same to its third & final reading. Ordinance No. 540 then declared passed.

Motion to declare Resolution No. 209 (purpose of providing a portion of the cost of improving the Water System by issuance of bonds in the principal amount of \$317,000 from Farmers Home Administration) an emergency, set aside rules & advance same to its third & final reading. Resolution No. 209 then declared passed.

Motion to declare Resolution No. 210 (purpose of providing a portion of the cost of improving the Water System by issuance of bonds in the principal amount of \$128,000 from Farmers Home Administration) an emergency, set aside rules & advance same to its third & final reading. Resolution No. 210 then declared passed.

Motion to declare Ordinance No. 541 (pertaining to two unusable Police vehicles) an emergency, set aside rules & advance same to its third & final reading. Ordinance No. 541 then declared passed.

Committee Reports.....

Administration/Public Safety - Submitted request of EMT meetings.

Treasurer - Receipts of \$35,877.74, expenditures of \$38,582.77 with a balance in general checking account of \$197,076.77.

Police Department - Chief Moore reported 19 arrests, 6 accidents, 13 assists to the Coast Guard, 12 medical runs & 26 minor injuries.

Planning Commission - all land splits must be recorded within 6 months from this date or the procedure will have to be started from the beginning.

Landfill - problem due to shortage of money. Clerk is to turn over all delinquent accounts to Village Solicitor & he will in turn, process them through Small Claims Court.

B.P.A. - it is four weeks away from going to bids for the Sweetbriar & Huntington project.

No reports from Finance nor Lands/Buildings

New Business.....

Motion passed to approve the K.I. Historical Society's request to use the Town Hall (in case of rain) for their annual Butterfly Festival, Saturday, September 15th.

Motion declared passed hiring Don St. Julian as K.I. Zoning Inspector for one year.

Motion passed to pay Ordinance No. 852.

Motion to adjourn to an executive session to discuss pending & threatening litigation passed.

Special Council Meeting, October 6th

Introduced Ordinance No. 542 entitled "An ordinance amending section 3 & 8 of Ordinance No. 539 passed Sept. 13, in order to correct the interest rate for the \$317,000 Waterworks Sys-

tem First Mortgage Revenue Bonds, series A authorized thereby, to adjust the principal payment schedule for that series & to adjust the monthly payments to & amount of, the Waterworks System Reserve Fund, & declaring an emergency."

Motion declared passed to suspend the rules requiring reading on three separate days for Ordinance No. 542.

Motion to pass Ordinance 542 as an emergency measure declared passed.

With legislation known as The Coinage Reform Act of 1989, if all goes as planned, our currency will include a new one dollar coin in 1992. As it would be the 500th anniversary of the celebrated discovery of America by Christopher Columbus, it will probably bear the image of this great explorer.

It would save the American taxpayer over \$318 million annually if a coin replaced the dollar bill because coins last 30 years while the bills last only 17 months. A coin costs 6 cents to produce & the dollar bill cost 2. / cents.

The failure of the Susan B. Anthony dollar coin a decade ago could have been because it was an alternate dollar, not exclusive & thereby a novelty. Also, it looked & felt like a quarter. The Columbus Dollar will be gold toned & have the benefit of hindsight thus avoiding these problems.

Legislation from October 11th Meeting.....

Motion to declare Ordinance No. 543 (contract hiring Poggemeyer/Port Study Consultant) an emergency, set aside rules & advance same to its third & final reading & contingent on approval of O.D.O.T., sending them copy of Poggemeyer's proposal & final figures. Ordinance No. 543 then declared passed.

Committee Reports.....

Finance - Request to check why the appropriation for the Police Department keep going higher each year. Statement made that due to a shortage of Landfill money, an additional bill may have to be sent out to property owners to cover additional bills Landfill is incurring. Committee will have to meet regarding same.

Streets/Sidewalks - Statement made there is a great amount of work that needs to be done this fall season; clearing brush, branches, cutting of trees at the airport, patching holes & berms with blacktop. Request to see agenda of jobs for the week ahead. Mayor stated he would like a short-term & long-term plan as to what we are going to do with Road Construction fund. Mayor suggested Haas & Ed Feick, Erie County Engineer, set up a meeting.

Lands/Buildings - Town Hall Roof has been repaired. Getting estimate on repair of the Town Hall's piano which was vandalized. Will check if it's insured, if not, bill for repair may be paid by any donations received. Pat Hayes said he could repair it for approx. \$500.00. Airport grant is at a stand-still. Grant to widen was asked for but somehow resurfacing came into it. County Engineer said we can't afford that improvement this year. A meeting with O.D.O.T. will be set up in October. We have to apply by the end of October for next year's resurfacing grant. The junk car situation at the airport is still being looked into. Village Solicitor is going to set up a procedure.

Administration/Public Safety - Training session for more firefighters is being planned. Fire Department's By-Laws are in the process of being revised.

Treasurer - Receipts of \$43,822.84, expenditures of \$90,469.46 with a balance of \$166,910.09 in general checking account.

Police Department - Chief Moore reported 38 complaints, 7 citations issued, 9 Medical runs, 5 traffic violations, 6 assists to Coast Guard, 21 other injuries, & daily patrols were made.

Planning Commission - Meeting was held to review the proposals requested for the Port Development Study & from 5 proposals chosen to review, decision was made to go with the Poggemeyer Design Group & submitted for Council's approval. Copy of Poggemeyer's proposal was given to all Council members. Motion to approve George Kushner's minor subdivision based on the fact that all conditions required under new subdivision rules were met, was passed.

Landfill - Reported that requirements requested in letter from E.P.A. would be taken care of. Signs were ordered & will be installed; more grass will be planted, but due to lack of funds, installation of Gas & Water Monitor Wells will have to wait. Response to their letter must be done by October 26.

B.P.A. - Reports bids were advertised to do general maintenance on the Water Tower which is in a deteriorating condition. The only bid came late, therefore will have to re-bid & done in the Spring. Solicitor reported Water Project as closed & will be started in the Spring.

New Business.....

Motion declared passed accepting amounts & rates set by the Budget Commission.

Fishin'.....by Grampa Walleye

At this time of the year, there is not much to write about fishin' so here's some observations made by me during the last month:

-Seen at the Seaway Marina Channel - some fellas had a gas powered generator & spread out a string of electrical lights for fishin' during the night, looked to me like the Cedar Point dock all lit up! I don't think it helped catch fish though.

-Fishin' for Walleye one evening & my lantern went out, couldn't start it. Up to that time (about 1½ hours) I never got a bite. There was a full moon & after a while I realized one didn't need a lantern only a flashlight. Within an hour I had three nice fish. Tried this method several times since, using a flashlight only when netting a fish & have caught fish. I could only guess that since the water is so clear (from the Zebra's filtering) the light from the lantern reflects off the rocks in the clear water & spreads out so the fish will not come in close. You might want to try it - works well for me.

-Walleye limit - State reducing limit from 6 to 5 fish in '91. I don't agree that this will help fish population to increase. I would be for a closed spawning season in spring - the newer sophisticated methods for finding fish are a Big Factor for taking a lot of fish filled with spawn in early spring. Need to repopulate & this is an important factor in the cycle. Maybe even a Fall regulation say, limit of 3 fish, after all the fish we're catching now are full of spawn.

Reminds me of the story about the two fish swimming together when the little fish asked the bigger fish, "How did you manage to grow so large?" "My friend," he replied, "when I was your size, I learned to keep my mouth shut, so here I am."

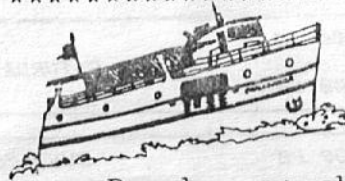
