## The Squatters

Before the Kelley brothers purchased the island, it had another name, Cunningham's Island, & other people did occupy the land. When we see property change hands today, we probably don't consider that many have owned it before us. Of course, there were the Indians, the British, the French (It was even once a part of the Province of Quebec.), & the citizens of Connecticut before it became Ohio. In 1817, Judge Jabes Wright surveyed the island & set up markers to show which properties had been granted to which members of the Connecticut Land Company. Those proprietors were John McClellan, Jabes Adams, Uriah Tracy, Daniel Tilden, Richard Coit, William Eldridge, Joseph Perkins, & Oliver Kinsman. These were the men who sold to the Kelleys. However, before them there were others who have been referred to as "squatters".

Probably the best known of the squatters was a Frenchman by the name of Cunningham, who had come to the island in 1808, & it was for him the island was first named. During the four years that he occupied the premises, he traded with Indians, buying maple sugar & animal skins in exchange for blankets, etc., & maybe whiskey. He built a rough cabin. It's a guess that he was killed by the Indians or the British in 1812, although tales were told that he was wounded, escaped to the mainland, had descendants in Olmsted Township, & is buried between Rocky River & Ely-

ria.

Two other Frenchmen, Bebo & Poschile, were also squatters. These two supposedly settled on the west point, & their clearing was taken over as a guard site for General Harrison's troops. It was said that these two left the island with Cunningham.

A man named Killam came with his family & another man or two around 1818. Although he built a cabin, he stayed only a couple years. During this time, he cut red cedar wood for the Walk-on-the-Water, the first steamboat on lake

Erie. When the boat was wrecked in 1820, Killam left the island. He had employed a couple men, Barnum & Grunmet, to help with the wood. Although he left, they stayed & became bitter enemies. This resulted in a shooting match in which Grunmet was killed. Barnum was jailed in Norwalk, Ohio. (then county seat of Cunningham's Island). He plead self-defense, & he was acquitted.

Several families followed: in 1827 Elisha Ellis & his wife; Sam Beardsley & his wife who died the same year; Henry Ellithorp who came in 1828 & brought his bride Elizabeth Neals across the ice on a sleigh along with six head of cattle in December, 1830; (She later gave birth to a boy, the first white child to be born on the island.) Ira B. Henderson & family; E.T. Smith, also known as "Tinker"; Nicholas Haskins with his wife & eight or nine children; Luther Ludd, his wife & four children; Frank Saunders; Ben Napier, with his family & five or six men in 1833. Napier had been ejected from Put-in-Bay. He was a large man of vile temper & took over property & livestock without any rights of ownership. Because of people like him, the squatters welcomed the rightful owners, the Kelley brothers, with open arms when they arrived on the scene. Many of these families remained to work for Irad & Datus, who soon established law, order & a community.

Although we don't have much information about these settlers, we feel that they too, have a place in our early history. In his own way each made a contribution in clearing overgrown land, building a home, maintaining a family, & sowing seeds of a civilization that we can enjoy

today.

## Pumpkin Crunch Cream Pie

3/4 cup cold milk
1 (3½ oz.) pk. Vanilla
 instant pudding & pie
 filling
1/2 cup solid-pack pumpkin
3/4 teasp. pumpkin pie
 spice

2/3 cup slivered
almonds
2/3 cup semi-sweet
chocolate chips
3½ cups (8 oz.) Cool
Whip, thawed
1 Graham Cracker Pie
crust

Pour milk into mixing bowl. Add pie filling mix. Beat with wire whisk until well blended. (1 minute) Let stand 5 minutes.

Blend in pumpkin, spice, almonds, chips & 2 cups of the Cool Whip. Spoon into pie crust.

Chill 4 hours.

Before serving, garnish with remaining Cool Whip & chocolate curls, if desired.

Remember sportsmen (& your dogs) that Lyme disease is still on the increase. In Connecticut, where the disease first surfaced fourteen years ago, 744 cases were reported in 1989.

Cases of Lyme disease have now been reported in 43 states. As you venture out this fall, keep a close eye on both your dog & yourself. Deer ticks will be active until the first heavy frosts.

The best way to avoid Lyme disease is to stay free of ticks. Inspect yourself & your dog thoroughly after every trip into the field. Hunters should tuck their pants into high socks & wear light-colored clothes which will enable them to spot deer ticks at once. Tightly woven fabrics also aid in repelling ticks.

Permethrin, applied to clothing discourges deer ticks. It permeates the cloth, killing most ticks which crawl over it. Used with a deet-containing product, it is considered to be one of the best repellents available. Before buying any tick repellent, be sure to read the label & follow the directions carefully.

Legislation from July 12th Meeting.....

Motion passed to declare Ordinance No. 536 (Amend. to Ord. No. 528 to adjust Truck Rates) an emergency, set aside rules & advance same to its third & final reading. Motion then declared passed.

Motion failed to reconsider previous action of Council for ordinance of Fresch's Island House rezoning.

Motion failed to declare an emergency, set aside rules & advance same to its third & final reading.

Motion passed to advance Fresch's Island House rezoning to its first reading.

Committee Reports.....

Finance - Budget meeting to be held Monday, July 16th at 9 am.

Streets/Sidewalks - Meeting would be held with Highway Department's Director & his assistant.

Lands/Buildings - Request letter of thanks be sent to Paul & Vicky Finnegan for the many hours of hard work they spent in beautifying the park.

Administration/Public Safety - Five resumes have been received from police officers & are being screened for hiring. Was stated that we did have police protection from the Sheriff of Erie County last weekend.

Treasurer - Expenditures as \$38,255.35, total receipts as \$21,015.10 & total in general checking account as \$199,831.80.

Police Department - No report.

Planning Commission - Motion passed approving Arlene Steuer's land split based on surveyor's drawing & contingencies now met. Suggested resignations from the Park Board if they so not get more active. Special Council meeting & Public Hearing will be held to consider Subdi-

vision Regulations. A Port Development Study meeting was held & a consultant will be chosen based on their proposal & what they will do for us.

Iandfill - The E.P.A. is still not satisfied with our Iandfill closure & suggested the Village haul dirt from the mainland for they find the Village dirt unsuitable. Stated Village get Gas & Water monitoring wells. Will meet again with them. We now have a chipper that will take care of 3" brush. We are fast running out of money. An ordinance will be introduced to adjust truck rates only. Will consider businesses paying for weight instead of truck load. Will need scales. Village Solicitor said lawsuits may have to be filed in small claims court regarding unpaid Iandfill fees. Once there is a judgment, a lien can be placed on the owner.

B.P.A. - Capacity of the present plant has to be expanded to meet the present needs.

Old Business.....

Motion passed for solicitor to prepare legislation to establish a \$250.00 deposit for cleanup of the Pavilion & Town Hall.

New Business.....

Motion declared passed approving use of the Pavilion for Steve Merkel on Saturday, Aug. 11, 1990 - Vertex Dev. Company Picnic.

Citizens Participation - Fresch's Island House addressed Council to reconsider their zoning. \$50,000 received from the Port Assistance Program Grant for shoreline study. Concern the island was without police protection over the 4th of July weekend. Request to spread gravel on Melody Iane. Asked if missing shingles will be replaced on Town Hall's roof. Answered that they are getting prices on same. Mayor advised letter regarding "water ban" will be sent & that notices for "ban on burning until further

notice" will be posted. Meeting to be called with Admin./Safety Committee. Reported work with the recycling committee & that we have to get recycling started before we can make it mandatory.

Items from Council - Letter read regarding questionable behavior at bars & serving minors. Stated that it will not be tolerated by Council. Motion declared passed to provide sufficient funds to Chief Moore so as to hire clerical help to send out registered letters to owners of junk cars.

Motion passed to pay Ordinance No. 850.

Public Hearing held regarding the 1991 budget.

Committee Reports.....

Finance - No report

Streets/Sidewalks - In meeting with ODOT, several promises were made but to date nothing has transpired.

Lands/Buildings - Reported that Mr. Feick is working on the widening of the airport. Request that the dates for parking stickers be changed to run from Nov. for a year. Cars that do not have current license tags should be impounded & kept at the landfill. Mayor & solicitor explained that their is a lengthy procedure that must be put into motion before impounding vehicles. A letter is being prepared to give to the clerk to inform those people who have stickers of the new dates for stickers. The K.I. Historical Assoc., Chamber of Commerce & Lands/Buildings met to discuss possible uses of the recently acquired Dwelle property. Motion passed for feasibility study for the Dwelle property use.

Administration/Public Safety - EMT's now have pagers & regular schedules worked out.

Treasurer - Receipts of \$35,794.74, expenditures of \$38,535.11 & \$197,324.43 in general checking account.

Police Department - Chief Moore reports 79 com-

plaints, 16 citations issued, 1 case of breaking & entering, 1 vandalism of road signs, 18 medical runs, 23 minor injuries, 21 assists to the Coast Guard. The Chief informed Council that he had an offer for one of the two old police vehicles at that time. Solicitor McDermond informed Council that before old police vehicles can be sold, legislation must be brought in declaring police vehicles unusable.

Planning Commission - They have approved a land split for Downtown rentals & request that Council approves the same. Motion passed to do so.

Landfill - Expenditures are exceeding receipts. Further study is needed as to what can be done.

B.P.A. - Solicitor McDermond reports that the part of the contracts dealing with the expansion of the plant are being processed with hopes of getting legislation before council for a special meeting soon. On an other phase of the water project, mainly the intakes, it has reached a critical stage. He has been in contact with the contractor in hopes that part of the project can be rebid. His office has been given the authority to expedite the Sweetbriar water lines which will be an assessed project.

New Business.....

Motion declared passed for the 1991 budget.

Motion passed to award General Liability Ins. Contract to T.M Steinemann & Associates.

Motion passed approving use of the Pavilion to Carol McDonald on Tuesday, Aug. 21, 1990.

Motion passed to pay Ordinance No. 851.

Harvest onions before ground freezes.

Well now, it seems with the temperature of the water starting to drop, the fish are starting to come back to the island, however, reports on the Perch fishin' is not too promising as of late. Perch are being caught in 30-40 feet of water both on the northwest end of the island & east of the airport, but they are running a lot smaller in size than they were a couple of months ago. Average is one keeper for every five to six fish caught, but they are worth the effort.

Walleyes are starting to come into the shallows at evening --- Ted Terry & some of his tenants at Sunrise Point caught fish on Friday & Saturday evening (10/5 -10/6). Fish were between 5 to 7 pounds, so they are a nice size. They are just starting to show up so as October "gets on" Walleye fishin' from shore should get better. Everyone has their favorite lure, I happen to like a Rapala, CD-7 (countdown) which is a slow sinking Balsa wood lure - use Silver Black finish as the Walleye's favorite food at this time of the year is the Shad & you want to simulate this bait fish. Get your lanterns cleaned up & mantels changed - try this fishin' - I'm sure you will like it (if the weather cooperates).

Took some of my grand-kids to the Marina to fish (ages 6-9) they had a good time catching some Small Mouth Bass & Crappies on minnows/bobber lines. It was really good for me - no one fell in which is really surprising - if you do this, make sure the kids have their preservers on, as little kids get excited easily when they

catch fish & accidents happen.

Did you notice how clear the water is around the docks on the island? The Zebra Mussels are really doing "their thing". Divers are saying "clear" goes down 15 - 20 feet & looking at old wrecks in Take Erie is really fun now due to the clear water. Although I personally feel the Mussels are hurting the fishin' during July, Aug. & Sept., I honestly hope these little critters are not impacting the spawning grounds in Western Take Erie, the economy of this whole section depends on the fishin'.

Hope each & everyone of you readers have a good autumn. Please drop me a line & let me know about your feelingson this & any fishin' you may do during the Fall/Winter months, Ohio, Florida or wherever, also any suggestions you may have. Thanks!

The renovations on the "Old Stone Church" are complete & the museum collection is growing.


