Great seeing Bibber Overcashier, Kate Boker & Bob Golias on their feet in & around Kelleys again, even though they still have their good & bad days.

Had visitors over the weekend which gave me the opportunity to browse in our gift stores. Always so involved at home that normally I miss the chance to visit them. Don't you follow suit! There are so many different gift ideas! Even some things that I want for myself....then there's Christmas!

The Corp of Engineers have finally approved the dock building for the new ferry line.

Still can't see much progress at the State Park except for paved parking at the Grooves.

There is a new fee being imposed on boaters using certain waterways (Lake Erie included) as of Sept. 1, 1991. According to the Coastguardsmen who dropped off the literature about this to K.I. Marinas, said 65% of the fee will go to the USCG. Maybe reading about their average day will help the "medicine" go down?

Fiscal year 1986 was an average year for the Coast Guard. Nothing unusual happened to make it different from our first 195 years. Yet, how can we call it average?

On an average day, we saved 19 lives — one life every 75 minutes. This is an average statistic, but a very important one to each person who is alive today because of us. During that same average day we assisted another 371 people and saved \$2,747,257 in property. We completed 159 search and rescue cases.

Coast Guard Marine Safety personnel worked 28 oil spills during that average day. They boarded 40 vessels for port safety checks. They inspected another 68. Because of this average day's work, explosions, sinkings, deaths and injuries were much less likely.

We seized 5,043 pounds of marijuana and 20 pounds of cocaine during that average day and helped other agencies confiscate 640 pounds of marijuana and three pounds of cocaine. We arrested two drug smugglers. The street value of the illicit drugs seized by Coast Guardsmen that day was \$5,909,206 — \$4,104 every minute. We also helped our sister agencies seize an additional \$761,973 worth of drugs. We seized a drug running vessel every two to three days.

During our average day, we spent \$5,054,800 to keep all of our boats, cutters and planes running. Our cutters and aircraft burned \$158,904 of fuel — enough to buy 184,770 gallons of regular unleaded gasoline. That is enough gasoline to heat 100,000 tons of water to 105.6 degrees Fahrenheit or drive a compact car around the Earth 222 times. Our payroll totals \$2,192,000 each day — \$1,522 each minute.

Thirteen marine casualties were investigated on our average day. More than 8,000 transactions took place on the Coast Guard's Marine Safety Information System — the largest system of its kind in the world.

As we go about our work in the Coast Guard, we often don't realize how much of an impact we have on this country and its people. Because of our "average" day with its average problems and average work, people are saved from the perilous sea, our channels are safely buoyed, ports and vessels are operated safely, the smugglers of death are stopped, incompetent seaman and poor vessels are removed from the sea and our waterways are cleaner than anytime in recent memory.

A lot of above average Coast Guard people, both military and civilian, make an average day in the Coast Guard something special. Maybe that's the reason our average day isn't so average. — LCDR Christopher Waller

Jake Hay Continued

Stories that are handed down from generation to generation often lose some of their credibility along the way. However, some of them become documented, & although there might not be "real proof" of all the words, they become a part of history. Such is the case for my "story" this month.

In the March-April 1991 issue of SeaScape, I introduced you to "One Versatile Man", Jake Hay. I'd like to continue with his adventures.

If you will recall, Jake had lived on Pelee Island for awhile before coming to Kelleys Island. In February of 1838, he went back to Pelee to check on a wheat crop he had planted, & he stayed there for five days.

A group of rebels against the Canadian Government had organized under the name of Patriot Army. They had been to Kelleys Island, trying to get some of the men there to join them. Jake had persuaded the men not to do so. On his return trip from Pelee, he encountered this Army walking across the ice. They were on their way to invade & plunder Pelee residents.

Nearly seven months later Jake went back to Pelee. When he arrived, he was accused of being a part of the Patriots, & the Pelee residents were determined to hang him. They took his rowboat, his only means of transportation away from the island. He escaped by swimming to Middle Island, a distance of nearly three miles to the south.

A man & a boy who lived on Middle Island gave him shelter, but refused to take him to Kelleys Island. The year before he had abandoned a dugout canoe because of a split in one end. He sawed off the split end, & nailing a board across, he made it tight enough to stay afloat with continual bailing. He paddled for Kelleys Island with nothing but a broken board, hoping to reach shelter before an approaching storm hit. With less than a mile to go, the storm did come, sweeping Jake & his canoe down the lake.



He broke loose a thwart or two & lashed them in the bow in the form of a cross. As he bailed water with an old nail keg aboard, he removed his shirt & hung it on the cross with the arms through the sleeves, thus making a sail. Then he used the board with which he'd been paddling for a rudder. He bailed constantly as the gale blew all day & all night.

On the second day he saw no land. At dusk the wind carried him toward the shore of Avon Point near Cleveland, where high waves dashed against the rocky shore. Knowing that his crude craft could be broken to pieces, he steered it away from this shore on down the lake.

By morning the storm had abated. People watching from shore saw the man in the strange craft paddling feebly toward them. They helped him ashore & took him to a nearby farmhouse at Dover Bay. After hearing his story, they took him to the home of Chester Dean a few miles away at Rockport.

After a few days rest at the Dean residence Jake walked to Cleveland where he was able to get passage on a boat bound for Sandusky, Ohio. He soon learned that the captain & his crew were drunk, & so Jake & a young woman passenger (whose husband was drunk, too) navigated the boat to the Huron River. At this point, Jake abandoned ship & walked to Sandusky. There he was able to get a boat to Kelleys Island. As he had been gone for two weeks & everyone assumed he had drowned, all were astonished & delighted to welcome him home & to hear the strange tale he had to tell.

Legislation from May 9th Meeting..... /

Committee Reports.....

Finance - Haas reported he met with County Auditor to discuss sidewalk assessment & is waiting for a report.

Streets/Sidewalks - Martin is waiting to hear from Feike. Village needs to know & approve what is going with sidewalks before any work is done.

Lands/Buildings - Haas reports that he is waiting to hear from Ed Feike on his bid for the project at the airport. Village must find out if they can get the 10% payment, before any work can be done. Funds not available at this time.

Administration/Public Safety - Matso reported that he is currently working on getting insurance for the EMT's. McCullagh wants to pass a motion to give EMT's liability & personal liability insurance. Also, to affiliate the EMT's with the police department. Motion to affiliate these together passed. Matso reported that the beer truck is being donated to the Village & should be on the island within a week. The truck will be used for recycling purposes.

Transfer Station - Haas reported that he was as far as possible on the availability fees, & that B.F.I. is where monies will be spent for the fees. Haas says the Village plans on getting own equipment, as soon as legalities are straightened out.

Park Board - Holdren reported that he has had two meetings with Erie Co. Park Board whereas the Village being part of Erie Co. so is our Park Board. Holdren wants clerk to fill out forms so that the Park Board can apply for grants. Want to get restrooms downtown & also scenic look-out points.

No reports from Treasurer nor B.P.A.

No Old Business was discussed.....

New Business.....

Motion declared passed to approve reservation request for Town Hall, June 8th, 1991 for K.I. School Graduation & for the Municipal Bldg. May 11th, 1991 for the Chamber of Commerce.

Citizens Participation.....

Why Sennish has to pay availability fee for 2 residences & a business...Why Yoscovits was relieved from his job on the Cemetery Board & requests letter stating reasons of his dismissal...Asked if Councilman Herndon pays for business availability fee, & also wants to know if State Park has to pay...When Harbor Lane is going to be fixed, discussion leads into repairs of Melody Lane & water assessment...When the Village is going to hire the new Police Chief, McCullagh reported that Sheriff's Dept. will be up on weekends until one is hired, how to reach police if needed, special meeting is being set up to decide new Chief of Police, phone no. to be posted to reach police, 625-7951... Request someone do something about the dump trucks from L.E.A.P. driving down the road over 45 mph, Matso to discuss situation with Ralph Kunar of Kellstone...EMT's turned in beepers as they don't work anyways, someone will check with phone co. on this, June Campbell & Dee Mack volunteered their nursing services if needed while EMT's are waiting for insurance, their phone nos. will be posted at the grocery stores ...Discussion of dump fees led into argument by Finger, who claims he will not pay the \$960.00 he is being charged, claims he will have someone from Sandusky come over & pick up his garbage.

Items from Council.....

Martin wants to know when Village is going to get its audit.

Motion passed to approve to pay Ordinance No. 859.

Legislation from June 20th Meeting.....

Motion to declare Ordinance No. 556 (Amending Ord. No. 481 - Wage increase Clerk/Treasurer) an emergency, set aside rules & advance same to its third & final reading passed.

Motion to declare Ordinance No. 557 (Amending Ord. No. 166 - Village Volunteer Fire Dept.) an emergency, set aside rules & advance same to its third & final reading passed.

Motion to declare Ordinance 558 (Transfer of money in General Fund from Village Workers Salaries Benefits to Legal/Council Contractual Service for payment to National Casualty for deductible payment) an emergency, set aside rules & advance same to its third & final reading passed.

Motion to declare Ordinance No. 559 (Establishing the salary & benefits for the Chief of Police) an emergency, set aside rules & advance same to its third & final reading passed.

Committee Reports.....

Finance - Herndon reported that the General Fund is in trouble. There is \$25,000 in obligations we will have to meet that money was not appropriated for. \$7,500 goes for a settlement to police officers, \$5,000 to pay Village deductible on an insurance claim, \$4,500 from Medical to sidewalk Debt. Service Fund & an \$8000 appropriation error. Possibilities to get General Fund out of trouble: A) Vehicle Road Use Tax - Charging fees of \$5.00 per car; \$10.00 per truck & \$20.00 per large truck for those vehicles that are registered to the Village of Kelleys Island. B) Head Tax - A charge of 50¢ per person, arriving on Kelleys Island. C) Herndon welcomes any suggestions from residence regarding the generation of more funds. Full discussion of this topic will be ready for next meeting.



Streets/Sidewalks - Martin waiting to hear from County Engineer on the streets. The Village is to see about getting help from the County to get the drains fixed & patched.

Lands/Buildings - Haas reported that the Village received an \$8,000 grant for the Airport waiting room.

Administration/Public Safety - Matso reported that Chief Schnittker is being assisted by one new officer & is in the process of hiring two more officers. Also, EMT's are now fully covered by Love Insurance.

Treasurer - Seeholzer reported that the Village Funds total \$47,422.01; the Water Funds total \$111,717.40; & the General Funds & Funds that support that fund total \$710.83 in the RED. The total Village monies come to \$252,083.86.

Police Department - Chief Schnittker reported on trying to keep the EMT's & Fire Dept. in communication with the Police. Reported on the 24 calls he's received since he became Chief.

Planning Commission - Herndon reported that D. Ahner is in the process of receiving a conditional use permit for the sale of liquor at Caddyshack. He must fulfill all requirements needed to have the conditional use permit (parking spaces, no drinking on putt putt course & railings around the outside patio). Motion to grant the conditional use permit declared passed.

Herndon also requested the help of the Clerk or the Asst. Clerk to take minutes at the Planning Commission meeting, while they are trying to replace their secretary. Motion to keep Clerk or Asst. Clerk on payroll while taking minutes for Planning Commission meetings, passed.

Motion declared passed for Yoscovits' quest for minor sub-division.

Poggemeyer working on Zoning Ordinance & maps, meeting with State Senator Montgomery, Council, Mayor McCullagh & Poggemeyer set for July 12, 1991. A public meeting will be scheduled soon after to generate materials to that point.

Transfer Station - Haas reported on the paying of Availability Fees:

Neufer referred to the cutting of the Airport grass & how there are 5 cars without license plates that he would like to remove from the airport property & move to the Village property. Chief Schnittker & Lee will be working together to get rid of the cars. Yoscovits wants to know when he is going to get the letter he requested on why he was relieved of his duties on the Cemetery Board. DeBoard wanted to know why the posting of one of the meetings did not explain the Resolution for the new Ferry Line. Gorchester would like to know who would be held liable if someone were to be injured on one of the defective sidewalks (property owner & Village). Yako discussed the large trucks on the road from 7 am to 5:30 pm saying how it was ruining the road & also going against the noise ordinance.

Old Business - Sidewalk assessment - Haas reported that they are not generating enough money to pay for the notes on accounts. Meeting with State Senator Montgomery to try to get help. On airport project bids, Haas reported that there is a holdup with Ed Fieke due to drainage problems.

New Business.....

Motion to order Erie County Bond Schedule for Mayor's Court declared passed.

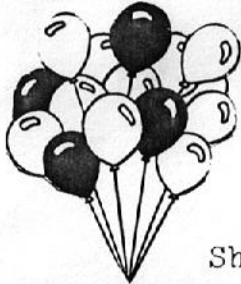

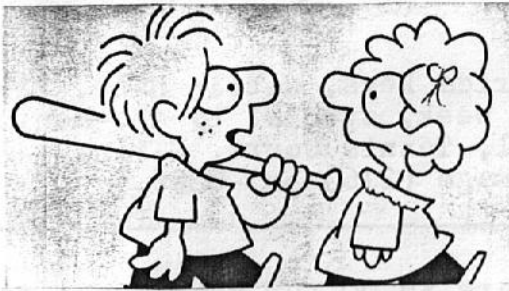
